# Town of Jackson Work Session 5:00 p.m. Thursday, August 07, 2025

#### 1. Call to Order

The regularly scheduled work session for the Town Council of the Town of Jackson, SC was called to order at 5:00 p.m. in the Council Chambers of the Jackson Municipal Complex located at 106 Main Street in Jackson, SC by Mayor Wiggins on Thursday, August 07, 2025.

#### 2. Invocation

Invocation was given by Councilmember Bates.

# 3. Carolina Connect Update

Council received a presentation from Carolina Connect regarding broadband availability and potential expansion within the Town of Jackson. The update outlined existing coverage areas and identified the necessary steps and considerations for extending service to currently unserved or underserved parts of the community.

4. Ordinance 25-11; Amend FY 24/25 Budget – SCIIP Construction Payment, Engineering Fees, Water Equipment Purchase, Police Laptop Purchase

Mayor Wiggins reviewed Ordinance 25-11. The ordinance will amend the FY24/25 Budget to include funding for:

- SCIIP construction and engineering services
- Purchase of water department equipment
- Purchase of laptops for the Police Department **Agenda item.**

# 5. Ordinance 25-12; Amend FY 24/25 Budget – PARD Grant / Engineering Fees for SCIIP Project

Mayor Wiggins reviewed Ordinance 25-12. The ordinance will amend the FY24/25 Budget to recognize PARD grant funding and provide for additional engineering fees associated with the SCIIP Project.

- **6. Ordinance 25-13; Amend FY 25/26 Budget Mosquito Grant, SCIIP Construction Payment, & Transfer to Ballpark Savings** Mayor Wiggins reviewed Ordinance 25-13. The ordinance will amend the FY25/26 Budget to:
- Record Mosquito Grant revenue
- Approve SCIIP construction payment
- Transfer excess FY25 funds into the Baseball Savings Account, the surplus attributed to revenue generated from two community baseball tournaments **Agenda item.**
- 7. Discussion Replacement of Cameras at Town Hall
  Council discussed the current condition of Town Hall surveillance cameras
  and the potential replacement or upgrade of the existing system.

- 8. Discussion Repair of Old Concession Stand

Council discussed using SRS Settlement Funds to cover the cost of the repairs, noting that this use falls in line with the Town's Business Grant Guidelines. **Agenda item.** 

**9. Discussion – Amendment to Tennis Court Resurfacing Quote** Council discussed the need to amend the current resurfacing quote for Thornton Park tennis courts based on revised scope and updated pricing to include adjustable pickleball netting and 5% contingency for unforeseen expenses related to the project. Project will be funded 80% PARD grant and 20% CPST4.

10. Discussion – Purchase of Portable Radio for SRO Position Council discussed the need to purchase two portable radios—one for the newly designated School Resource Officer and one as an additional unit. The purchase will be funded through the Police Capital Outlay account, with one radio reimbursable at 100% through the SRO Grant. The bid provided reflects state contract pricing.

11. Discussion - Purchase of Police Vehicle for SRO Position Council discussed acquiring a new police vehicle for use by the SRO. Purchase will be funded by Police-Capital Outlay and reimbursed 100% by SRO Grant. Bid included is state contract price. Agenda item.

12. Discussion - Agreement with SC Department of Juvenile Justice Council reviewed agreement with the SC Department of Juvenile Justice regarding juvenile. This would renew the agreement an additional year. Agenda item.

# 13. Discussion – Agreement with CivicPlus

Council reviewed a service agreement with CivicPlus to provide online code hosting and updating.

14. Discussion - Atomic Road Well Radio Transmitter Repair Council received an update on the Atomic Road well site. The current transmitter has failed, and options are being reviewed for either a 6-channel upgrade or SCADA system.

# 15. Mayor's Report

1. Mayor Wiggins provided an update on the Main Street Sidewalk Grant 2. He will work on getting quotes to make repairs at the food distribution center next to the senior center.

## **Standing Committee Reports**

Parks & Recreation- Councilmember Willingham reported that he is currently coordinating several improvements in preparation for the annual Hook & Cook Festival. Items under consideration include:

- Installation of a new speaker system
- Upgrades to electrical hook-ups
- Installation of fencing along the back side of the property
- Replacement of event banners
- Dirt and sod installation in the area where a tree fell during Hurricane

He also noted that football sign-ups are currently in progress and that Jackson will be hosting the Jamboree this year.

In addition, Councilmember Willingham is in the process of obtaining quotes for limbing work at Thornton Park.

Sanitation- No report.

Police- Chief Sparling reported that he is scheduled to meet with the Town Attorney at 1:00 p.m. on Tuesday, August 12, 2025, to discuss challenges faced by Code Enforcement in reaching the owners of nuisance properties. These challenges include properties owned by individuals currently in nursing homes. out-of-state owners, and those held by LLCs.

Streets and Drains- Councilmember Bates reported that he submitted a list of maintenance concerns to SCDOT, which included requests for trimming and pothole repairs at various locations throughout the Town.

He also noted that the Town has purchased a backpack sprayer, appropriate chemicals, and protective masks with filters for mosquito spraying efforts.

In addition, Councilmember Bates reported that, according to SCDOT, Burroughs Street is scheduled to be paved within the next four weeks. This paying will address areas impacted by recent sidewalk replacement and repair work. Fire-Councilmember Greene reported that the Fire Department plans to provide a hot dog dinner during the Town's Tree Lighting event on December 4th. This effort will serve as both a fundraising opportunity and a way to give back to the community.

Water- Councilmember Teuton informed Council that the Chief of Police has offered the use of the Police Department's Crown Victoria vehicle for the Water Department to assist with meter reading, should the department experience another vehicle shortage. Written report attached to the minutes.
